



## Privacy Policy

Canuck Door Systems Co. is an Ontario registered Corporation that service, repair and install commercial doors and windows. The Privacy Policy describes what kind of personal information we collect about you when you use our services and how Canuck Door Systems treats it. The Canuck Door Systems Privacy Policy's effective date is August 1, 2017.

### **Types of Personal Information:**

Companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this Policy carefully to understand what we do.

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Employer Name
- Business address
- E-Mail Address
- Phone Number
- Cell Number
- Birthday

Canuck Door Systems collects some information during the advertising campaigns in digital media. Also, information can be collected when you use our website or interact with us via e-mails. We can also collect your personal information from other sources, such as credit bureaus, affiliates, or other companies.

### **Consent**

Knowledge and consent are required for the collection, use or disclosure of Personal Information except where required or permitted by law. Providing us with your Personal Information is always your choice. However, your decision not to provide certain information may limit our ability to provide you with our products or services. We will not require you to consent to the collection, use, or disclosure of information as a condition to the supply of a product or service, except as required to be able to supply the product or service.

## **Information tracking technology**

Cookies are small pieces of data that are stored on your computer, mobile phone or other devices. Pixels are small code blocks on a website that allow for another server to measure viewing of a webpage and often are used in connection with cookies.

Canuck Door Systems uses these technologies in order to improve your experience with the site. Cookies store anonymous information, such as whether you viewed the website from your mobile device or computer. Some personal information may be stored in a cookie and/or pixel, such as the website that you visited immediately prior to visiting the Canuck Door SYstems website and relevant information that allows us to improve your user experience and for marketing purposes. Additionally, Canuck Door Systems may use a cookie and/or that only store anonymous information to track visitors across websites in order to better customize our marketing and advertising campaigns.

We use analytics tools such as called “Google Analytics” to collect information about your usage of this website. These analytics services collect information such as how often you visit this website, what pages you visit, and what other websites you visit prior to coming to the Canuck Door Systems website.

These Analytics Services only collect the IP address assigned to you on the date you visit this site, not your name or other identifying information. Canuck Door Systems does not combine this type of information with personally identifiable information.

## **Personal information use**

All companies need to share clients’ personal information to run their everyday business. Canuck Door Systems collects and use your personal information for various purposes, including but not limited to, creating of individually tailored advertisement, delivering related content, process your transactions, maintain your account (s), and other purposes related to the IncomeClub services.

IncomeClub does not share your personal information with any third parties except as permitted or required by law such as respond to a court order, legal investigations, report to credit bureaus, or taking actions regarding illegal activities and suspect fraud.

We do not share your personal information with any affiliates.

You and Canuck Door Systems have mutually understood and agreed, that any personal information that you provide through the Canuck Door Systems website for purpose of public use, may be publicly available at our discretion, and that other people can reproduce such information in various manners. We do not control how other people can use your voluntarily provided information.

Canuck Door Systems can deliver you the information about our products, services, news, articles published on our blog by e-mails. If you make a decision that you are no longer wish to receive this information, you can unsubscribe from our email delivery at any time by using “Unsubscribe” instructions provided in e-mails.

## **Personal Information Protection**

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computers, servers, networks and procedural safeguards, secured files and buildings.

Law gives you the right to limit only information for affiliates and for non-affiliates to market to you
